The Fiscal Court held a Special Meeting for the purpose of meeting as a Committee of the Whole for EDA Director Lucas Witt gave an update on the Yokohama project, discuss the proposed text amendments to Articles II and VII in the Versailles-Midway-Woodford County Zoning Ordinance and have public comment for same.

Yokohama Project Update

Director Witt gave an update on due diligence activities related to the Yokohama project. Multiple inspections and evaluations have been completed at a cost of approximately \$21,000, which is well below the projected budget. Overall findings indicate the building is in very good condition, with minor roof repairs and limited HVAC unit replacements identified as the primary items for further review. An update was also provided on funding, including the receipt of a \$100,000 economic development grant contingent upon state funding, with KPDI recommendations expected soon. Staff reviewed next steps, retaining due diligence timelines, and current market conditions, noting strong industrial demand and limited available inventory in the region.

Judge/Executive Kay gave background information on the proposed city–county partnership to purchase the former Yokohama Industries property. Yokohama was a major employer in Woodford County, and acquiring the site would help preserve existing industrial land, support job replacement with quality employers, protect occupational tax revenue, and avoid future industrial development on farmland. The purchase would also allow local control over the type of industry located at the site, preventing less desirable uses and supporting long-term economic and farmland preservation goals.

There were no questions raised by court members for Director Witt on this matter.

Proposed Zoning Text Amendment to Articles II and VII

Judge/Executive kay recognized Squire Taylor would introduce changes regarding the proposed Zoning Text Amendments Articles II and VII. Two types of proposed changes were outlined: immaterial changes that do not alter the substance of the legislation and may proceed to first reading, and material changes that would require referral back to the Woodford County Planning Commission for review. The court recognized Whitney Stepp as the newly appointed Chair of the Planning Commission. The court noted that public comment would be accepted within a designated time limit, with guidance for group representation. The meeting then transitioned to Squire Taylor beginning a detailed review of the proposed text amendments, starting with Article II.

Article 2 – Definitions

- Squire Taylor noted very few recommended changes overall and no recommended changes to Article 2 itself.
- Article 2 primarily:
 - Updates and expands definitions, many tied to state law (KRS).
 - Removes outdated or redundant language.
 - Aligns local definitions with current KRS references (e.g., agricultural use, board of adjustments, manufactured housing, FEMA, recreational vehicles).
- New or clarified definitions include:
 - Accessory buildings (clearly distinguished from RVs, buses, mobile homes).
 - Family member definition — identified as highly impactful.
- Significant concern raised by court members:

- Definition of *immediate family* was narrowed to parent → child and grandparent → grandchild only.
- Removed relationships include:
 - Child → parent
 - Spouse → spouse
 - Sibling → sibling
 - Grandchild → grandparent
- Court acknowledged this would immediately change family conveyance rights if adopted.

Article 7 – Zoning District Changes (Major Focus)

- Proposed structural zoning changes:
 - Elimination of A-2 zone, converted to A-1
 - A-4 converted to Small Community (SC)
 - Discussion about Rural Residential Farmland
- Clarifications and updates:
 - Removal of “tourist destination” as a principal use in A-1.
 - Addition of safety services and utilities.
 - Clarification that accessory dwellings are singular, not multiple.
 - Consistency fixes where plural vs. singular wording created ambiguity.

Parks Definition Issue

- Squire Taylor made the recommendation to specify “public parks” to prevent unintended uses (e.g., ATV parks, theme parks).
- County Attorney cautioned this may be material, as prior language intentionally removed public/private distinctions.

In-Family Conveyance (Major Area of Debate)

Proposed changes included:

- Minimum lot size recommended at 1 acre (Planning Commission proposed 2 acres).
- Equal allowance of two in-family conveyances regardless of farm size 31 acres or greater.
- Five-year holding period of conveyed property:
 - Does not begin until:
 - Home is constructed and Grantee establishes residency (certificate of occupancy issued).
- Five-year holding period of primary property.
- Residency of the primary parcel requirement reinstated prior to in-family conveyance (previously requested by the Fiscal Court to be included but was omitted by the Planning Commission).
- Restrictive covenant and reverter clause proposed:
 - Property would revert to original grantor if:
 - Sold early, or
 - Residency requirement violated.
- Water service certification required before approval:
 - New development must not impair existing service.
 - Infrastructure upgrades paid by the developer if needed.

Concerns raised by court members:

- Squire Gill stated that the reverter clauses may:
 - Prevent financing or mortgages.
 - Be difficult or impossible to enforce.
 - Create legal uncertainty if original grantor is no longer owner.
- Planning & Zoning previously viewed reverter clauses as unenforceable.
- Enforcement currently relies mainly on pre-plat requirements, not post-conveyance penalties.
- Squire Gill also expressed concern that proposed language could effectively freeze land, preventing sale or use if a home is never built.

Conservation (CO) District Changes

- Squire Taylor strongly opposed Planning Commission recommendation:
 - Could allow large tracts to be subdivided into many small lots.
 - Viewed as inconsistent with farmland preservation goals.

- Planning Commission proposal would reduce minimum lot size from 30 acres to 5 acres.
- Recommendation by the court members was to retain the 30-acre minimum.

Rural Residential / Residual Farmland

- Squire Taylor discussed in the proposal changes from the Planning Commission:
 - Reduction from 15 to 10 lots per 100 acres.
 - Continued requirement for setbacks, road frontage, and infrastructure.
- Added requirement:
 - Residual farmland must be contiguous and regularly shaped to support actual agricultural use.
- Clarification expressed by Squire Brown:
 - Existing developments allowed green space to be fragmented.
 - New language might restrict flexibility previously used to make layouts work.

Process & Timing Concerns

Squire Gill noted that even without sending amendments back to Planning Commission, adoption would still take several months and sending changes back to the Planning Commission could delay adoption another year. Squire Gill recommended the court consider a moratorium on building permits if delays continue.

Closing Notes

- Squire Taylor recommended adoption of immaterial changes.
- Court members acknowledged the need for:
 - Careful review,
 - Clear understanding of consequences,
 - Transparency due to significant property rights impacts.

Public Comment

Due to time constraints, the public comment was held during the allotted time on the Regular Meeting Agenda.

Adjournment

With no objection from the committee, the meeting was adjourned at 5:29 p.m.

The Committee of the Whole met prior to the Regular Meeting January 13, 2026, and received an update from EDA Director, Lucas Witt, on the Yokohama project, including due diligence findings, carrying costs, and the proposed purchase timeline. Judge/Executive Kay clarified that carrying costs have been fully discussed and identified, with the intent that they be bonded, and rejected claims that the project constitutes real estate speculation. It was emphasized that Yokohama's closure was due to corporate business decisions, not a lack of workforce, and that Woodford County maintains a strong labor market. Judge/Executive Kay also addressed concerns regarding the EDA's 5% share of net sale proceeds, noting it was reduced from an initial 20% request and does not present a conflict of interest. Finally, Judge/Executive Kay noted that alternative industrial sites are not comparable or available, and that acquiring the Yokohama property would allow the county and city to attract quality employers and prevent conversion to non-job-producing uses such as warehousing.

The court proceeded to consider the **proposed text amendments to Articles II and VII**. Initial discussion was held by the Committee of the Whole, but concluded earlier than anticipated, prompting the decision to reopen discussion on the amendments for further consideration. (See minutes for the Special Meeting January 13, 2026)

Squire Varner recommended proceeding with the version of the amendments returned by the Planning Commission, following the County Attorney's guidance. He stated that taking this approach would allow progress to continue, avoid delays in the timeline, manage growth responsibly, and move the process in the right direction for the evening.

Squire Downey requested clarification from the County Attorney regarding the proposed change within the Conservation District from a 30-acre minimum to a 5-acre minimum, as suggested by Squire Taylor, and asked what actions could be taken by the Court during the current meeting and what the required process would be. Judge/Executive Kay clarified that the existing ordinance language included the 30-acre minimum and noted that the Fiscal Court had previously sent that existing language to the Planning Commission in its original form for review. The County Attorney clarified that the original submission to the Planning Commission did not address any change to the acreage requirement because there was no intent by the Fiscal Court for it to be changed at that time.

It was noted that the record reflects discussion by the Planning Commission regarding why they considered changes, and that Squire Gill provided interpretation of how the Planning Commission evaluated the matter. The County Attorney stated that if it was not clearly communicated that the Fiscal Court wished the acreage requirement to be considered for change, then the Fiscal Court may rely on its review of the ordinance to determine whether the existing acreage requirement was appropriate.

The Judge stated for the record that returning the language to the original provision of a 30-acre minimum—consistent with what the Fiscal Court initially sent to the Planning Commission—should be considered an immaterial change to the proposed text amendments to Articles II and VII, as recommended by Squire Taylor.

Squire Gill asked the County Attorney to review the new material submitted by Squire Taylor and explain what a material change is and what is an immaterial change.

The court took a brief recess for the County Attorney and Assistant County Attorney to review those proposed changes with Squire Taylor.

The County Attorney explained that, upon reviewing what the Fiscal Court originally sent to the Planning Commission, it became clear that the court had requested consideration of a requirement that applicants for intrafamily conveyances be Woodford County residents. That requirement was discussed and considered by the Planning Commission but was not included in the version returned to the Fiscal Court. Because the request originated with the Fiscal Court, the court may choose to insert that residency requirement back into the ordinance by vote, which would require renumbering the affected provisions.

He further clarified that other changes made by the Planning Commission—such as altering the 30-acre requirement—were not requested by the Fiscal Court, and therefore the court may restore the original language if it chooses. He noted that issues such as definitions related to public parks could be addressed later through Article II and, if desired, sent back to the Planning Commission for consideration.

Before voting, the County Attorney emphasized that the key decision for the court is whether to include the residency requirement for intrafamily conveyance applicants, as this was the primary unresolved item requiring clarification prior to final action.

Residency Requirement to Article VII relating to In-family Conveyance (1:32:28)

A motion was made by Jackie Brown and seconded by Darrell Varner to send the recommendation back to the Planning Commission to include the Woodford County residency to apply for in-family conveyance, as included in the Fiscal Court's original recommendation to the Planning Commission back in the text amendment.

Squire Gill explained that the Planning Commission discussed the residency requirement at length and removed it because many farms in Woodford County are owned by individuals who live outside the county. The Commission felt it would be unfair to restrict in-family conveyances based on residency when the property owners are still Woodford County landowners, even if their primary residence is elsewhere.

Squire Varner withdrew his second.

8. A motion was made by Jackie Brown and seconded by Liles Taylor to send the recommendation back to the Planning Commission to include the Woodford County residency to apply for in-family conveyance, as included in the Fiscal Court's original recommendation to the Planning Commission back in the text amendment. **(Attachment)**

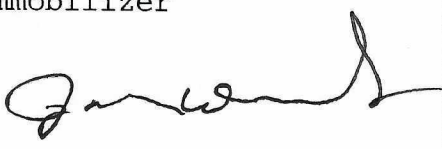



Dear Judge Kay:

The Administrative Office of the Courts, Division of Audit Services, has audited the expenses of the Woodford County Kentucky Court of Justice (KCOJ) facility for the period of July 1, 2024 – June 30, 2025 (FY 2025). This report is a summary of the field work completed. Our responsibility is to review and evaluate expenses for reimbursement and budgetary projections. For this FY 2025 audit, we are auditing for compliance with Administrative Office of the Courts *Policies for the Operation and Maintenance of Court Facilities* (“the Policies”) dated February 2018.

When reviewing expenses, it is sometimes necessary to deny reimbursement for expenses that were not incurred in accordance with the Policies, were not authorized operating costs per the Policies, or were coded incorrectly as operating costs. Most commonly, expenses are denied due to a lack of background check for maintenance or janitorial workers with access to KCOJ-occupied areas of the facility or failure to obtain advance approval from AOC for nonrecurring projects. The requirements outlined in the Policies are not meant to create barriers for counties to obtain reimbursement. Rather, they are put in place to ensure the security of confidential court records and to ensure that sufficient funds are available in the limited statewide maintenance budget to properly maintain all court facilities statewide and address emergent needs.

If your county has an approved nonrecurring project, please submit invoices and proof of payment to the Department of Court Facilities at facilitiesrequest@kycourts.net for reimbursement.

Attached with this letter is the following information for your records:

- A Cost Summary Report showing a comparison of FY 2025 estimated expenses and actual expenses. You will also see where we have compared the FY 2025 actual expenses to the FY 2024 and FY 2023 actual expenses for future planning purposes.
- 3 reports (if applicable) classified as:
 - Report #1 Reimbursement Denied
 - Report #2 Unauthorized Expenses
 - Report #3 Non-KCOJ Expenses

An explanation of each report that may be attached to the Cost Summary Report is below:

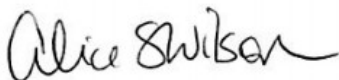
- Report #1 Reimbursement Denied - will list expenses where prior approval from AOC was not obtained by the local unit of government consistent with the requirements listed above.
- Report #2 Unauthorized Expenses - will list expenses defined as not necessary for the operation of the KCOJ facility.
- Report #3 Non-KCOJ Expenses - will list expenses that are not related to the KCOJ Facility or KCOJ occupied portion of the facility.

As noted during last year's engagement letter and final report, if your county collects court facility fees, these should be recorded in account code 4561-Fiscal Court Filing fees per the Department for Local Government memo dated July 29, 2020 and deposited into the General Fund to be used for court facility purposes pursuant to KRS 23A.220, 64.091, or 24A.185. That memo further states that court facility fee expenditures should be recorded in account code 5081 – Judicial Center AOC.

For this FY2025 audit, we reviewed the receipt and expenditure of court facility fees. Your county appears to be recording the receipt and expenditure of court facility fees appropriately.
